### 4. FIRST AID MEASURES

If poisoning occurs, contact a doctor or Poisons Information Centre (Phone Australia 131 126, New Zealand 0800 764 766).

**Inhalation:** Remove victim from exposure - avoid becoming a casualty. Remove victim from exposure - avoid becoming a casualty. Remove contaminated clothing and loosen remaining clothing. ## 6. ACCIDENTAL RELEASE MEASURES

### SMALL SPILLS

Contain - prevent run off into drains and waterways. Use absorbent (soil, sand or other inert material). Collect and seal in properly labelled containers or drums for disposal. ## 7. HANDLING AND STORAGE

**Handling:** Avoid skin and eye contact and inhalation of vapour, mist or aerosols.
