HEALTH HAZARDS

HEALTH HAZARDS - No TWA has been established for Forane[®] 410A. A manufacturer suggests 1000 ppm TWA. A manufacturer reports that inhalation of very high concentrations may cause temporary alteration of the heart's electrical activity with irregular pulse, palpitations or inadequate circulation. Nitrogen is an asphyxiant.

SIGNS AND SYMPTOMS OF EXPOSURE: Nitrogen is an asphyxiant. Significant dilution of ambient air by asphyxiants causes air hunger, increased breathing frequency, drowsiness, weakness, and ringing in ears.
