

### 4.1 Description of first aid measures

#### Inhalation

- | IF INHALED: Remove victim to fresh air and keep at rest in a position comfortable for breathing. Administer oxygen if breathing is difficult. Give artificial respiration if victim is not breathing. If signs/symptoms continue, get medical attention.

### 5.3 Advice for firefighters

### 7.1 Precautions for safe handling

#### Handling

Be aware of any signs of dizziness or fatigue, especially if work is done in a poorly ventilated area; exposures to fatal concentrations of this gas mixture could occur without any significant warning symptoms, due to olfactory fatigue or oxygen deficiency. Wear appropriate personal protective equipment, avoid direct contact. Cylinders should be firmly secured to prevent falling or being knocked-over. Do not attempt to repair, adjust, or in any other way modify cylinders. If there is a malfunction or another type of operational problem, contact nearest distributor immediately. Empty containers retain product residue and can be hazardous. Do not cut, weld, puncture or incinerate container.
