Section 4 First Aid Measures

Emergency and First Aid Procedures

Section 5 Firefighting Procedures

Extinguishing Media: Use alcohol resistant foam, carbon dioxide, dry chemical, or water spray when fighting fires. Do not direct a water stream directly into the hot burning liquid.

Steps to Take in Case Material Is Released or Spilled:
