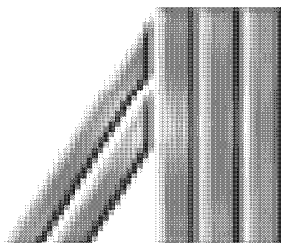

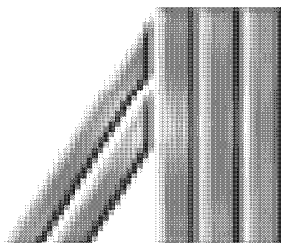

Spill or Release Procedures: Highway or railway spills call chemtrec (800) 424-9600 cont. U.S. Collect (202) 483-7616 from Alaska and Hawaii.

Stay upwind and away from spill. Keep all sources of ignition and hot metal surfaces away from spill. Keep out of drains, sewers, or waterways. Use sand or other inert material to dam and contain spill. Do not flush with water; use absorbent pads. For large spills call response team and notify appropriate state/local agencies. 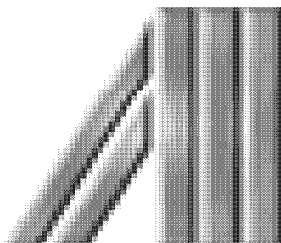

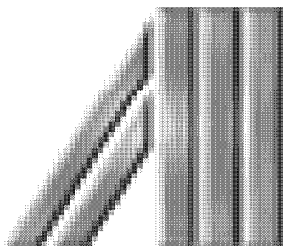
