6. ACCIDENTAL RELEASE MEASURES

Spillage

If the cylinder is leaking, eliminate all potential ignition sources and evacuate area of personnel. Prevent spreading of vapours through drains and ventilation systems. Inform manufacturer/supplier of leak. Use personal protective equipment. Carefully move material to a well ventilated remote area, then allow to discharge. Do not attempt to repair leaking valve or cylinder safety devices.

7. STORAGE AND HANDLING

Storage

Do not store near sources of ignition or incompatible materials. Cylinders should be stored below 45°C in a secure area, upright and restrained to prevent cylinders from falling. Cylinders should also be stored in a dry, well ventilated area constructed of non-combustible material with firm level floor (preferably concrete), away from areas of heavy traffic and emergency exits.

Handling

Use of safe work practices are recommended to avoid eye or skin contact and inhalation. Do not drag, drop, slide or roll cylinders. The uncontrolled release of a gas under pressure may cause physical harm. Use a suitable hand truck for cylinder movement.

Material to Avoid Moist carbon dioxide is corrosive, hence acid resistant materials are required (stainless steel). Certain

properties of some plastics and rubbers may be affected by carbon dioxide, ie. embrittlement, leaching of

plasticisers, etc. Corrosive when moist.

Decomposition This material will not decompose to form hazardous products.

11. TOXICOLOGICAL INFORMATION

Health Hazard Asphyxiant gas. Carbon dioxide concentrations of 3-5 % in air cause increased respiration and headache. Summary Concentrations of 8-15% cause headache, nausea and vomiting which may lead to unconsciousness if not moved

Concentrations of 8-15% cause headache, nausea and vomiting which may lead to unconsciousness if not moved to open air and given oxygen. Inhalation of a mixture containing no oxygen may result in unconsciousness from the first breath and death may follow in minutes. Adverse health affects to long term exposure to carbon dioxide

have not been reported.
