## 2. Hazards Identification

<b>Physical state</b>	Liquid.
<b>Appearance</b>	Clear, yellowish liquid.
<b>Emergency overview</b>	Physical and health hazard information on reagent mixtures have not been determined. Contains animal source material of U.S. origin. The human hCG in this preparation was tested by FDA-approved methods and found to be negative for the presence of hepatitis B virus surface antigen (HBsAg), human immunodeficiency virus (HIV) 1 & 2 and hepatitis C virus (HCV). However, because no test method can provide complete assurance that infectious agents are absent, this product should be handled as a potentially biohazardous material in accordance with universal/standard precautions.

<b>First aid procedures</b>
