## 6. Accidental release measures

### Personal precautions, protective equipment and emergency procedures

Keep unnecessary personnel away. Keep people away from and upwind of spill/leak. Wear appropriate protective equipment and clothing during clean-up. Do not breathe dust. Use a NIOSH/MSHA approved respirator if there is a risk of exposure to dust/fume at levels exceeding the exposure limits. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. Ensure adequate ventilation. Local authorities should be advised if significant spillages cannot be contained. For personal protection, see section 8 of the SDS.

### Methods and materials for containment and cleaning up

Sweep up or gather material and place in appropriate container for disposal. Minimize dust generation and accumulation. If sweeping of a contaminated area is necessary use a dust suppressant agent which does not react with the product. Contain the spill, then place in a suitable container. For waste disposal, see section 13 of the SDS. Prevent entry into waterways, sewer, basements or confined areas.

### Environmental precautions

Avoid discharge into drains, water courses or onto the ground. If large quantities enter a waterway, advise local authorities.

Provide appropriate exhaust ventilation at places where dust is formed. Do not breathe dust. Do not taste or swallow. Avoid contact with eyes, skin, and clothing. Avoid prolonged exposure. When using, do not eat, drink or smoke. Should be handled in closed systems, if possible. Wear appropriate personal protective equipment. Wash hands thoroughly after handling. Observe good industrial hygiene practices.

Store in a dry place. Store in original tightly closed container. Store in a well-ventilated place. Store away from incompatible materials (see Section 10 of the SDS). Keep away from food, drink and animal feedingstuffs.
