## 4. FIRST AID MEASURES

## 6. ACCIDENTAL RELEASE MEASURES

**SMALL SPILLS:** Wipe up with absorbent (clean rag or paper towels). Allow absorbent to dry before disposing with normal household garbage.

**LARGE SPILLS:** Slippery when spilt. Avoid accidents, clean up immediately. Wear protective equipment to prevent skin and eye contact. Contain - prevent run off into drains and waterways. Use absorbent (soil, sand or other inert material). Collect and seal in properly labelled containers or drums for disposal.

Store in cool place and out of direct sunlight. Keep containers closed when not in use - check regularly for leaks.
