Precautions for safe handling

Conclusion/Summary : **Oxirane, 2-methyl-, polymer with oxirane, monobutyl ether**: Post-mortem examinations on rats following subacute, whole body, inhalation studies of polyalkylene glycols (average MW 1700) revealed concentration-related lesions of the lung including interstitial pneumonitis, bronchoalveolar cell hyperplasia and intra-alveolar macrophage infiltration (Klonne et al, 1987). Exposure-related mortalities did occur. The LC₅₀ values were determined to be 4,670 mg/M³ in male rats and >5,230 mg³ in female rats. Other subacute studies identified minimal to moderate intra-aveolar cellular debris and foci of interstitial pneumonitis at 492 mg/M³ and aveolar macrophage infiltration at 50.6 mg/M3 and above (DuPont, 1985). Exposure-related mortalities did occur. The approximate lethal concentration (ALC) was 2,900 mg/M³. A LOAEL was determined to be approximately 500 mg/M3 (Lewis, 1995). In another inhalation study with rats, observed histopathological changes were confined to lungs of the treated animals (Union Carbide, 1991). No exposure-related mortalities occurred and lung damage had resolved by the end of a six week recovery period.
