

Practically non-irritating to eyes and to the skin. Practically non-toxic by inhalation (LC₅₀ >5mg/L) based on testing of similar products in rats.

1,2-Benzenedicarboxylic acid, di-C9-11-branched alkyl esters, C10-rich: Practically non-irritating to eyes and to the skin. Practically non-toxic by inhalation (LC₅ >5mg/L) based on testing of similar products in rats. A 2-generation reproductive toxicity study conducted on this material did not identify any effects on reproductive parameters. However, the study did identify a small increase in early offspring mortality at the high oral dose level. Based on studies with laboratory animals, oral maternal exposure to this component can result in developmental toxicity to the conceptus. The NOAELs established from these studies were 38 to 44 mg/kg-bw/day during pregnancy and 52 to 114 mg/kg-bw/day during lactation.

Distillates (petroleum), solvent-dewaxed heavy paraffinic: Mineral oil mists derived from highly refined oils are reported to have low acute and sub-acute toxicities in animals. Effects from single and short-term repeated exposures to high concentrations of mineral oil mists well above applicable workplace exposure levels include lung inflammatory reaction, lipoid granuloma formation and lipoid pneumonia. In acute and sub-acute studies involving exposures to lower concentrations of mineral oil mists at or near current work place exposure levels produced no significant toxicological effects.
