4. First-aid measures

Conditions for safe storage, including any incompatibilities	Store tightly closed and in properly labelled container in a dry, cool and well ventilated place. Containers that have been opened must be carefully resealed and kept upright to prevent leakage. Keep away from direct sunlight and heat. Store away from incompatible materials (see section 10). Keep off freezing.

Eye	If risk of contact with eyes wear chemical splash goggles. Depending on conditions of use, a face shield may be necessary.
