5. FIREFIGHTING MEASURES

5.1	Fire & Explosion Hazards:	In operation, batteries generate and release flammable hydrogen gas. 7. HANDLING & STORAGE INFORMATION

7.1	Work & Hygiene Practices:	Store batteries under roof in cool, dry, well-ventilated areas that are separated from incompatible materials and from activities that may create flames, spark, or heat. Store on smooth, impervious surfaces that are provided with measures for liquid containment in the event of electrolyte spills. Keep away from metallic objects that could bridge the terminals on a battery and create a dangerous short-circuit. Handle carefully and avoid tipping, which may allow electrolyte leakage. Single batteries pose no risk of electric shock but there may be increasing risk of electric shock from strings of connected batteries exceeding three 12-volt units.
7.2	Storage & Handling:	Use and store in a cool, dry, well-ventilated location (e.g., local exhaust ventilation, fans) away from heat and direct sunlight. Store in closed containers. 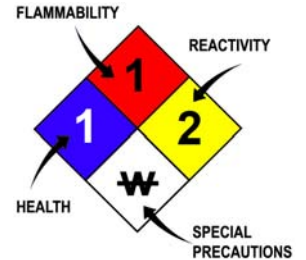
