**Most important symptoms and effects, both acute and delayed:** Inhalation of oil mists or vapors generated at elevated temperatures may cause respiratory irritation. ## SECTION 6: Accidental release measures

**Personal precautions, protective equipment and emergency procedures:** This material may burn, but will not ignite readily. Keep all sources of ignition away from spill/release. # **SECTION 7: Handling and storage**

**Precautions for safe handling:** Keep away from flames and hot surfaces. Wash thoroughly after handling.
