SECTION 2 - HAZARDS IDENTIFICATION

EMERGENCY OVERVIEW:

POTENTIAL HEALTH EFFECTS:

May Contain: Calcium Sodium Borosilicate, Synthetic Fluorophlogopite, Titanium Dioxide, Iron Oxides, Ultramarines, Carmine, Manganese Violet, Ferric Ferrocyanide, Blue 1 Lake, Bismuth Oxychloride, Chromium Oxide Greens, Yellow Lake 5.

SECTION 4 - FIRST AID MEASURES
