### **SECTION 2 - HAZARDS IDENTIFICATION**

#### **EMERGENCY OVERVIEW:**

This is a personal care or cosmetic product that is safe for consumers and other users under intended and reasonably foreseeable use. Additional information on toxicological endpoints is available from the supplier upon request.

#### **POTENTIAL HEALTH EFFECTS:**

- **Eye:** Contact may cause mild, transient irritation. Some redness and/or stinging may occur.

Active ingredient: Benzoyl Peroxide

Other ingredients: Water, Sodium Lauryl Sulfate, Cocamidopropyl Betaine, Polypropylene, Glycerin, Acrylates Crosspolymer, Polysorbate 20, Triethanolamine, Disodium EDTA, Phenoxyethanol, Methylparaben, Ethylparaben, Propylparaben.

The product(s) does not contain ingredients considered hazardous as defined by OSHA, 29 CFR 1910.1200 and/or WHMIS under the HPA.

#### SECTION 4 - FIRST AID MEASURES

- **Eye:** Thorough rinsing for 15-20 minutes of the affected eye with water is recommended. If discomfort or irritation persists, contact a physician.
