SECTION 2 - HAZARDS IDENTIFICATION

May Contain: CI 77891/Titanium Dioxide, CI 77491, CI 77492, CI 77499/Iron Oxides, CI 77007/Ultramarines, CI 77510/Ferric Ferrocyanide, Ferric Ammonium Ferrocyanide, CI 77288/Chromium Oxide Greens, CI 77289/Chromium Hydroxide Green.
