### 4. FIRST AID MEASURES

## 6. ACCIDENTAL RELEASE MEASURES

<b>Personal Precautions</b>	ELIMINATE all ignition sources (no smoking, flares, sparks or flames in immediate area). Evacuate personnel to safe areas. Keep people away from and upwind of spill/leak.
