3. HAZARDOUS IDENTIFICATION

EMERGENCY OVERVIEW: WARNING. Keep away from food. Vapor harmful. Do not ship in aluminum trailers. Vapors are heavier than air and will collect in low areas.

POTENTIAL HEALTH EFFECTS

EYE CONTACT: Liquid is moderately irritating to the eyes. High vapor concentrations may also be irritating.

INHALATION: Excessive exposure to this product may cause headache, CNS depression, drowsiness, dizziness, loss of appetite, irritation of the respiratory tract, drunkenness, unconsciousness, or death.

INGESTION: Liquid is moderately toxic and may be harmful if swallowed; may produce CNS depression. Ingestion of product may result in vomiting; aspiration (breathing) of vomitus into the lungs must be avoided as even small quantities may result in aspir. pneumonitis.

SKIN CONTACT: Liquid is moderately irritating to the skin. Prolonged or repeated contact can result in defatting and drying of the skin which may result in skin irritation and dermatitis (rash).

SIGNS AND SYMPTOMS OF EXPOSURE:

Early to moderate CNS depression may be evidenced by giddiness, headache, dizziness, and nausea; in extreme cases, unconsciousness and death may occur. Aspiration pneumonitis may be evidenced by coughing, labored breathing and cyanosis.

4. FIRST AID MEASURES

EYE CONTACT: Immediately flush eyes with plenty of water for at least 15 minutes while holding eyelids open. If irritation persists, get medical attention.

INHALATION: Remove to fresh air. If not breathing, give artificial respiration. If breathing is difficult, oxygen should be

administered by qualified personnel. Get medical attention immediately.

INGESTION: DO NOT INDUCE VOMITING. If vomiting occurs spontaneously, keep head below hips to prevent aspiration of liquid into the lungs. Get medical attention.

SKIN CONTACT: Remove contaminated clothing/shoes. Flush skin with water. Follow by washing with soap and water. If irritation occurs, get medical attention. Do not reuse clothing until cleaned.

AGGRAVATED MEDICAL CONDITIONS:

Preexisting eye, skin and respiratory disorders may be aggravated by exposure to this product. Impaired function from preexisting disorders may be aggravated by exposure to this product. Prolonged exposure above the OSHA permissible exposure limits may result in liver and kidney damage.

SUPPLEMENTAL HEALTH INFORMATION:

This product is listed as a carcinogen or potential carcinogen by NTP, IARC, and OSHA. Methylene chloride is listed under IARC as a 2B. A recent NTP study on perchloroethylene has determined that there is clear evidence of carcinogenicity (liver) in both male and female mice, clear evidence of leukemia in male and female rats and some evidence of animal carcinogenicity (kidney tumors) in male rats. The NTP study exposed rats to 200 and 400 ppm and mice to 100 and 200 ppm in a lifetime study.

5. FIRE FIGHTING MEASURES

Use water fog, "alcohol" foam, dry chemical, or CO2.

SPECIAL FIRE FIGHTING PROCEDURES:

Firefighters should wear proper protective equipment and self-contained breathing apparatus with full facepiece in positive pressure mode. Move containers from fire area if it can be done without risk. Use water to keep fire-exposed containers cool.

UNUSUAL FIRE AND EXPLOSION HAZARDS:

Although chlorinated solvents in this product will not burn, vapors concentrated in a confined or poorly ventilated area could be ignited upon contact with a spark, flame or high intensity energy source.

COMBUSTION PRODUCTS:

Carbon monoxide and unidentified organic compounds may be formed during combustion. Decomposition or burning can produce hydrogen chloride or possible traces of phosgene.

6. ACCIDENTAL RELEASE MEASURES

STEPS TO BE TAKEN IN CASE MATERIAL IS SPILLED OR RELEASED:

Immediately evacuate the area. Provide maximum ventilation. Unprotected personnel should move upwind of spill. Wear protective equipment as given in Section 8. Dike around spills to prevent spreading. Prevent contamination of surface and ground waters. Recover spilled material on absorbents, such as sawdust or vermiculite, and sweep into closed containers for disposal. After all visible traces, including ignitable vapors, have been removed, thoroughly wet vacuum the area. Do not flush to sewer. If area of spill is porous, remove as much earth and gravel, etc. as necessary and place in closed containers for disposal.

7. HANDLING AND STORAGE

PRECAUTIONS TO BE TAKEN IN HANDLING AND STORAGE:

Keep containers tightly closed when not in use. DO NOT cut or weld empty drums unless thoroughly cleaned. Do not ship in aluminum trailers. Chlorinated solvents can damage aluminum trailers which could ultimately result in an environmental spill.

OTHER PRECAUTIONS:

KEEP OUT OF REACH OF CHILDREN! Empty containers retain product residue and can be dangerous. Do not pressurize, cut weld, braze, solder, drill, grind, or expose such containers to heat, flame, sparks static electricity, or other sources of ignition.

8. EXPOSURE CONTROL/PERSONAL PROTECTION

RESPIRATORY PROTECTION:

If exposure may or does exceed occupational exposure limits (Sec. 2) use a NIOSH approved respirator to prevent overexposure. In accord with 29 CFR 1910.134 use an airline respirator or self-contained breathing apparatus when concentrations exceed permissible limits.

VENTILATION:

Provide exhaust ventilation sufficient to keep the airborne concentration of this product below its exposure limits. Exhaust air may need to be cleaned by scrubbers or filters to reduce environmental contamination.

PROTECTIVE GLOVES:

For limited service only: Viton (R), Silver Shield (R), Poly vinyl alcohol (degrades in water).

EYE PROTECTION:

Use chemical safety goggles and/or full face shield where splashing is possible. Contact lenses should not be worn when working with this material. Maintain eye wash fountain and quick-drench facilities in work areas.

OTHER PROTECTIVE CLOTHING OR EQUIPMENT:

Wear gloves and protective clothing which are impervious to this product for the duration of anticipated exposure, if there is potential for skin contact.

Use good personal hygiene when handling this product. Wash hands after use, before eating, drinking, smoking, or using the toilet.

ENGINEERING CONTROLS:

Do not use in poorly ventilated or confined spaces without proper respiratory protection. Facilities storing or utilizing this material should be equipped with and eyewash facility and a safety shower.
