## Section 4 - First Aid Measures

### 4.1 Description of first aid measures

#### Inhalation

- IF INHALED: Remove victim to fresh air and keep at rest in a position comfortable for breathing. Administer oxygen if breathing is difficult. Give artificial respiration if victim is not breathing. If signs/symptoms continue, get medical attention.

#### Skin

- If frostbite has occurred, seek medical attention immediately; do NOT rub the affected

area(s) or flush them with water. In order to prevent further tissue damage, do NOT attempt to remove frozen clothing from frostbitten areas. If frostbite has not occurred, immediately and thoroughly wash contaminated skin with soap and water.

**Eye**

- If eye tissue is frozen, seek medical attention immediately; if tissue is not frozen, immediately and thoroughly flush the eyes with large amounts of water for at least 15 minutes, occasionally lifting the upper and lower eyelids. If irritation, pain, swelling, lacrimation or photophobia persist, get medical attention as soon as possible.

**5.2 Special hazards arising from the substance or mixture**

**Unusual Fire and Explosion Hazards** • **EXTREMELY FLAMMABLE**  
Will form explosive mixtures with air.

Cylinders exposed to fire may vent and release flammable gas through pressure relief devices.  
Containers may explode when heated.  
Ruptured cylinders may rocket.

**5.3 Advice for firefighters**

- Structural firefighters' protective clothing provides limited protection in fire situations ONLY; it is not effective in spill situations where direct contact with the substance is possible.  
Wear positive pressure self-contained breathing apparatus (SCBA).  
**DO NOT EXTINGUISH A LEAKING GAS FIRE UNLESS LEAK CAN BE STOPPED**  
Move containers from fire area if you can do it without risk.  
**FIRE:** If tank, rail car or tank truck is involved in a fire, ISOLATE for 1600 meters (1 mile) in all directions; also, consider initial evacuation for 1600 meters (1 mile) in all directions.  
**FIRE INVOLVING TANKS:** ALWAYS stay away from tanks engulfed in fire.  
**FIRE INVOLVING TANKS:** Fight fire from maximum distance or use unmanned hose holders or monitor nozzles.

FIRE INVOLVING TANKS: Withdraw immediately in case of rising sound from venting safety devices or discoloration of tank.

FIRE INVOLVING TANKS: Cool containers with flooding quantities of water until well after fire is out.

FIRE INVOLVING TANKS: Do not direct water at source of leak or safety devices; icing may occur.

FIRE INVOLVING TANKS: For massive fire, use unmanned hose holders or monitor nozzles; if this is impossible, withdraw from area and let fire burn.

## Section 6 - Accidental Release Measures

### 6.1 Personal precautions, protective equipment and emergency procedures

#### Personal Precautions

- Ventilate the area before entry. Do not walk through spilled material. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing.

#### Emergency Procedures

- ELIMINATE all ignition sources (no smoking, flares, sparks or flames in immediate area). As an immediate precautionary measure, isolate spill or leak area for at least 100 meters (330 feet) in all directions. Keep unauthorized personnel away. Keep out of low areas. Stay upwind. LARGE SPILL: Consider initial downwind evacuation for at least 800 meters (1/2 mile)

### 6.2 Environmental precautions

- Prevent entry into waterways, sewers, basements or confined areas.

### 6.3 Methods and material for containment and cleaning up

#### Containment/Clean-up Measures

- All equipment used when handling the product must be grounded. Stop leak if you can do it without risk. If possible, turn leaking containers so that gas escapes rather than liquid. Use water spray to reduce vapors; do not put water directly on leak, spill area or inside container. Do not direct water at spill or source of leak. Isolate area until gas has dispersed.

## Section 7 - Handling and Storage

### 7.1 Precautions for safe handling

#### Handling

- Keep away from heat and ignition sources – No Smoking. Use only with adequate ventilation. Be aware of any signs of dizziness or fatigue, especially if work is done in a poorly ventilated area; exposures to fatal concentrations of this gas mixture could occur without any significant warning symptoms, due to olfactory fatigue or oxygen deficiency. Take precautionary measures against static charges. Use only non-sparking tools. All equipment used when handling the product must be grounded. Use explosion-proof - electrical, ventilating and/or lighting equipment. Cylinders should be firmly secured to prevent falling or being knocked-over. Do not attempt to repair, adjust, or in any other way modify cylinders. If there is a malfunction or another type of operational problem, contact nearest distributor immediately. Empty containers retain product residue and can be hazardous. Do not cut, weld, puncture or incinerate container.

### 7.2 Conditions for safe storage, including any incompatibilities

#### Storage

- Cylinders should be stored in dry, well-ventilated areas away from sources of heat, ignition and direct sunlight. Do not allow area where cylinders are stored to exceed 52C (125F). Cylinders must be protected from the environment, and preferably kept at room temperature approximately 21C (70F). Protect cylinders against physical damage. Cylinders should be firmly secured to prevent falling or being knocked-over.

#### Engineering Measures/Controls

- Good general ventilation should be used. Ventilation rates should be matched to conditions.
