Odor: Odorless

Low hazard for usual industrial or commercial handling by trained personnel.

Under normal conditions of processing and use, exposure to the chemical constituents in this product is unlikely, but operations (e.g. overheating, burning, abrading, machining) that can create airborne dust or vapors should be avoided. All ingredients are tightly bound in a polymeric matrix that has a negligible vapor pressure so there is a low potential for inhalation or ingestion of ingredients.

HAZARDS IDENTIFICATION

FlatWrap 2535 is an advanced textile structure engineered to facilitate the installation of round wire bundles into tight or confined spaces. Woven with lightweight thermoplastic yarns, the product maintains wire bundles in a flat, low profile. By forcing the wires to lay in a flat position, the bundle size is reduced, allowing routing through confined areas such as under carpet, headliner, under seat and door harness applications.

Potential Health Effects

Inhalation: Dust or fumes from burning this material may cause respiratory irritation with coughing, difficulty in breathing or shortness of breath.

Eye Contact: Dust and decomposition products may cause eye irritation.

HANDLING AND STORAGE

Storage: Store in a cool, dry place out of direct sunlight. Keep container closed.

Engineering Controls: Provide adequate ventilation. If dust or fumes are generated during use, use local exhaust in combination with general ventilation as necessary to remove fumes/dust from the workers' breathing zone and to ensure exposures do not exceed applicable limits.

Respiratory Protection: During dust-raising work or inhalation of hot/molten material: Use a NIOSH-approved respirator (See 29 CRF 1910.134, respiratory protection standard).

Eye Protection: Use tight fitting goggles if dust is generated.

Hand Protection: Gloves are recommended for prolonged use.
