6. Accidental release measures

Do not handle lenses until all sealant has been cleaned from the finger and hands. Adequate ventilation should be provided so that exposure limits are not exceeded. Product releases methanol during application and curing.

Methods and material for containment and cleaning up: Wipe, scrape or soak up in an inert material and put in a container for disposal. Wash walking surfaces with detergent and water to reduce slipping hazard. Wear proper protective equipment as specified in the protective equipment section.

Environmental Precautions: Prevent runoff from entering drains, sewers, or streams.

Precautions for safe handling: Sensitivity to static discharge is not expected. Methanol is formed during processing. Wear appropriate personal protective equipment. Use only in well-ventilated areas. Keep away from food, drink and animal feeding stuffs. When using do not eat, drink or smoke. Keep containers tightly closed.
