### SECTION 3 - COMPOSITION AND INGREDIENTS

PEG-4, Magnesium Sulfate, PEG/PPG-300/55 Copolymer, Polyethylene, Polypropylene, Laureth-23, Stearyl Alcohol, Dioleoyl ethyl Hydroxyethylmonium Methosulfate, Cetyl Alcohol, Behentrimonium Chloride, Distearyl dimonium Chloride, Hydroxypropylcellulose, Fragrance, Methylparaben, Propylparaben, Niacinamide, Alcohol, Hexylene Glycol, Blue 1 Lake.

The product(s) does not contain ingredients considered hazardous as defined by OSHA, 29 CFR 1910.1200 and/or WHMIS under the HPA.

### SECTION 4 - FIRST AID MEASURES

- **Eye:**
