Other Ingredients: Water, Sodium Laureth Sulfate, Sodium Lauryl Sulfate, Cocamide MEA, Zinc Carbonate, Glycol Distearate, Dimethicone, Sodium Xylenesulfonate, Fragrance, Cetyl Alcohol, Guar Hydroxypropyltrimonium Chloride, Magnesium Sulfate, Sodium Chloride, Sodium Benzoate, Ammonium Laureth Sulfate, Magnesium Carbonate Hydroxide, Benzyl Alcohol, Methylchloroisothiazolinone, Methylisothiazolinone.

The product(s) does not contain ingredients considered hazardous as defined by OSHA, 29 CFR 1910.1200 and/or WHMIS under the HPA.

### SECTION 4 - FIRST AID MEASURES

- **Eye:**
