Water, Sodium Lauryl Sulfate, Sodium Laureth Sulfate, Cocamidopropyl Betaine, Glycol Distearate, Dimethicone, Sodium Citrate, Cocamide MEA, Sodium Xylenesulfonate, Fragrance, Citric Acid, Sodium Benzoate, Guar Hydroxypropyltrimonium Chloride, Sodium Chloride, Tetrasodium EDTA, Ammonium Laureth Sulfate, Jasminum Grandiflorum (Jasmine) Flower Extract, Postelsia Palmaeformis Thallus Extract, Zea Mays (Corn) Silk Extract, Red 33, Blue 1, Methylchloroisothiazolinone, Methylisothiazolinone.

The product(s) does not contain ingredients considered hazardous as defined by OSHA, 29 CFR 1910.1200 and/or WHMIS under the HPA.

### SECTION 4 - FIRST AID MEASURES
