### SECTION 3 - COMPOSITION AND INGREDIENTS

Water, PVP, Chitosan, Lactic Acid, Polysorbate 20, PEG-40 Hydrogenated Castor Oil, Phenoxyethanol, Fragrance, Polysorbate 80, PEG-60 Almond Glycerides, Methylparaben, Disodium EDTA, Ethylhexylglycerin.
