SECTION 2 - HAZARDS IDENTIFICATION

Water, Stearyl Alcohol, Behentrimonium Methosulfate, Cetyl Alcohol, Bis-Aminopropyl Dimethicone, Fragrance, Benzyl Alcohol, Dicetyldimonium Chloride, Disodium EDTA, Hydrolyzed Silk, Lilium Hybrid Extract, Zea Mays (Corn) Silk Extract, Red 33, Methylchloroisothiazolinone, Methylisothiazolinone.
