Water, Sodium Laureth Sulfate, Sodium Lauryl Sulfate, Cocamidopropyl Betaine, Sodium Chloride, Viola Odorata Flower/Leaf Extract, Punica Granatum Extract, Fragrance, Cocamide MEA, Sodium Benzoate, Citric Acid, Sodium Citrate, Tetrasodium EDTA, Guar Hydroxypropyltrimonium Chloride, Linoleamidopropyl PG-Dimonium Chloride Phosphate, Methylchloroisothiazolinone, Methylisothiazolinone, Sodium Xylenesulfonate, Blue 1, Red 33.
