Water, Stearyl Alcohol, Behentrimonium Methosulfate, Zea Mays (Corn) Silk Extract, Postelsia Palmaeformis Thallus Extract, Jasminum Grandiflorum (Jasmine) Flower Extract, Fragrance, Cetyl Alcohol, Bis-Aminopropyl Dimethicone, Benzyl Alcohol, Dicetyldimonium Chloride, Disodium EDTA, Methylchloroisothiazolinone, Methylisothiazolinone, Red 33, Blue 1.
