SECTION 2 - HAZARDS IDENTIFICATION

EMERGENCY OVERVIEW:

Water, Sodium Laureth Sulfate, Sodium Lauryl Sulfate, Sodium Sulfate, Cocamidopropyl Betaine, Citric Acid, Sodium Chloride, Fragrance, DMDM Hydantoin, Tetrasodium EDTA.
