### SECTION 3 - COMPOSITION AND INGREDIENTS

Water, Sodium Laureth Sulfate, Sodium Sulfate, Sodium Lauryl Sulfate, Cocamidopropyl Betaine, Fragrance, Citric Acid, Sodium Benzoate, Disodium EDTA, Methylchloroisothiazolinone, Methylisothiazolinone, Styrene/Acrylates Copolymer.
