**Battery:** Alkaline Manganese Dioxide Zinc button cell (A76): The glow stick uses 3x button cell A76 which are locked by a screw in the cap. Special apparatus is needed to gain access. Keep A76 batteries away from small children due to potential ingestion hazard. For accidental exposure or ingestion please refer to Alkaline Manganese Dioxide Zinc (Miniature) PSDS.

### **SECTION 3 - INGREDIENTS**

**MATERIALS:** Case – PC, battery – A76 (Alkaline Manganese Dioxide Zinc button cells), cap – ABS, Neck lanyard with safety buckle and LED

#### **SECTION 4 – FIRST AID MEASURES**

Under normal circumstances, the flashlight is not hazardous.

**Ingestion:** Not a likely means of exposure. Batteries are concealed inside the compartment. If battery is accidentally swallowed, do not induce vomiting or give food or drink.
