7. HANDLING AND STORAGE

Handling Precautions Avoid contact with eyes, skin, or clothing. Avoid breathing vapors. Wash hands after use. Launder contaminated clothing before reuse. Slippery when wet. Ground and bond containers when transferring from one container to another.

Storage Information Store away from oxidizers. Store in a cool well ventilated area. Keep container closed when not in use. Keep from heat, sparks, and open flames. Product has a shelf life of 24 months.
