## SECTION 4 — FIRST AID MEASURES

### 4.1 First Aid Measures

- Eye Contact:** Immediately flush eyes with plenty of water occasionally lifting the upper and lower eyelids. Check for and remove any contact lenses. Continue to rinse for at least 20 minutes. Get Medical Attention.
- Inhalation:** Remove victim to fresh air and keep at rest in a position comfortable for breathing. If breathing is irregular or if respiratory arrest occurs, provide artificial respiration or oxygen by trained personnel. It may be dangerous to the person providing aid to give mouth to mouth resuscitation. Maintain an open airway. Get medical attention if symptoms occur.
- Ingestion:** Wash out mouth with water. If material has been swallowed and the exposed person is conscious, give small quantities of water to drink. ### 6.3 Materials & Methods to Contain and Cleanup

**Spill Control Measures:** Prevent the spread of any spill to minimize harm to human health and the environment if safe do so. Wear complete and proper personal protective equipment following the recommendation of Section 8 at a minimum. Dike with suitable absorbent material like granulated clay. Dispose of according to Federal, State, Local, or Provincial regulations. Used fluid should be disposed of at a recycling center.

**Containment and Cleanup:** Stop leak if without risk. Move containers from spill area. Approach release from upwind. Prevent entry into sewers, water courses, basements or confined areas. Wash spillage's with non-combustible, absorbent material e.g. sand earth vermiculite or diatomaceous earth and place in container for disposal according to local regulations. Dispose of via licensed waste disposal contractor. Contaminated absorbent material may pose the same threat hazard as the spilled product.
