Primary Routes of Entry:

Skin: Tests on similar materials indicate that no significant adverse health effects are expected to occur with short term exposure.

Eyes: Tests on similar materials suggests that minimal irritation may occur on contact.

Ingestion: Tests on similar materials indicate no significant adverse effects expected. Practically non-toxic.

Inhalation: Tests on similar materials indicate no acute effects are expected.

Section 6 First Aid Measures

Handling and Storage Precautions: Keep away from flames, sparks or hot surfaces. Never use a torch to cut or weld on or near container. Empty containers can contain explosive vapors. NFPA Class IIIB storage.

Do not allow product to freeze. If product freezes allow product to thaw completely prior to use.

Work/Hygienic Practices: Wash thoroughly after handling. Do not use gasoline, solvents, kerosene, or harsh abrasive skin cleaners for washing exposed skin areas. Take a shower after work if general contact occurs. Remove soaked clothing and launder before reuse. Launder or discard contaminated shoes and leather gloves.
