PRIMARY ROUTES OF ENTRY & EFFECTS OF OVER EXPOSURE:

Eyes: May cause slight irritation but does not injure eye tissue.

Skin: Frequent or prolonged contact may cause irritation.

Inhalation: Direct inhalation of aerosol mist can cause irritation of nasal and respiratory passages. Abusive or excessive inhalation may cause irritation to the upper respiratory tract, dizziness, nausea and other central nervous system effects.
