### **SECTION 2 - HAZARDS IDENTIFICATION**

**SECTION 4 - FIRST AID MEASURES**

**• Eye:**

Following accidental eye exposure, thorough rinsing of the affected area for 15-20 minutes with clean cold water is recommended. If discomfort or irritation persists, contact a physician. If the eyes or face becomes swollen during or following use, consult a physician or emergency room immediately.

**• Skin Problem:**

Thoroughly rinse with water. Discontinue use of product. If discomfort persists and/or the skin reaction worsens, contact a physician immediately. **• Fire Fighting Instructions:** Contact emergency personnel. Use self-contained breathing apparatus and full protective gear, if large quantities of product are involved. Hazardous

decomposition products may be released. Thermal degradation may produce oxides of carbon and/or nitrogen; hydrocarbons and/or derivatives. Thermal degradation may also produce oxides of silicone. Decomposition of hydrogen peroxide will release oxygen which will increase the explosive limit range and burning rate of flammable materials.

## SECTION 6 - ACCIDENTAL RELEASE MEASURES

- **Conditions for Safe Storage:**

Store in a well ventilate, cool area. Avoid contamination. Store in the original tightly capped containers away from sunlight, heat, sparks and flame. Decomposition of hydrogen peroxide may occur with increase in pressure and possible container rupture. Store in accordance with local requirements for Class 1 Oxidizers.
