SODIUM PERCARBONATE 80 – 100 %

SECTION 3: PHYSICAL DATA.

WHITE ODORLESS POWDER.

SECTION 4: STABILITY AND REACTIVITY

STABLE UNDER NORMAL CONDITIONS. CONTACT WITH WATER MAY RESULT IN SLOW DECOMPOSITION AND RELEASE OF OXYGEN. AVOID CONTACT WITH ACIDS, ALKALIS OR REDUCING AGENTS.

SECTION 5: HEALTH HAZARD DATA.

SWALLOWING - MAY CAUSE VOMITING OR DIARRHEA. MAY BE HARMFUL OR FATAL IF SWALLOWED.

INHALATION – MAY CAUSE IRRITATION OR BURNS TO RESPIRATORY TRACT.

SKIN CONTACT - MAY CAUSE IRRITATION.

SECTION 6: FIRST AID PROCEDURES

SWALLOWING - IF SWALLOWED **DO NOT INDUCE VOMITING**. GIVE 1 -2 GLASSES OF WATER. CALL A PHYSICIAN IMMEDIATELY. NEVER GIVE ANYTHING BY MOUTH TO AN UNCONSCIOUS PERSON. NOTE TO PHYSICIAN : TREAT SYMPTOMATICALLY AND SUPPORTIVELY.

SKIN CONTACT - WASH SKIN WITH LARGE AMOUNTS OF WATER 15 MINUTES WHILE REMOVING CONTAMINATED CLOTHING. WASH CLOTHES BEFORE REUSE. EYE CONTACT - RINSE EYES WITH LARGE AMOUNTS OF WATER FOR 15 MINUTES, AND LIFT LOWER AND UPPER EYE LIDS OCCASIONALLY. SEEK MEDICAL

ATTENTION IF IRRITATION PERSISTS.

SECTION 7: STORAGE

STABILITY - PRODUCT IS STABLE UNDER NORMAL CONDITIONS OF USE. STORE IN A DRY VENTILATED AREA AND KEEP CONTAINER SEALED. KEEP AWAY FROM SOURCES OF IGNITION.

ELIMINATE ALL SOURCES OF IGNITION. VENTILATE AREA OF LEAK OR SPILL. CLEAN UP PERSONNEL REQUIRE PROTECTIVE CLOTHING. CONTAIN AND RECOVER LIQUID WHERE POSSIBLE - FOR SPILLS TO DRAINS, FLUSH DRAIN WITH LARGE VOLUMES OF WATER.
