Water, Glycerin, Isohexadecane, Petrolatum, Dihydroxyacetone, Isopropyl Isostearate, Nylon-12, Aluminum Starch Octenylsuccinate, Dimethicone, Dimethiconol, Stearyl Alcohol, Hydroxyethyl Acrylate/Sodium Acryloyldimethyl Taurate Copolymer, Cetyl Alcohol, Behenyl Alcohol, Squalane, Benzyl Alcohol, Tocopheryl Acetate, Glyceryl Stearate, PEG-100 Stearate, Xanthan Gum, Disodium EDTA, Ethylparaben, Propylparaben, Methylparaben, Caprylic/Capric Triglyceride, Polysorbate 60, Fragrance, Red 33, Yellow 5.
