**SECTION 2 - HAZARDS IDENTIFICATION**

**EMERGENCY OVERVIEW:**

Water, Petrolatum, Mineral Oil, Hydroxypropyl Starch Phosphate, Fragrance, Stearyl Alcohol, Mica, Polysorbate 60, Titanium Dioxide, DMDM Hydantoin, Cetyl Alcohol, Triethoxycaprylylsilane, Disodium EDTA, Phenoxyethanol, Iodopropynyl Butylcarbamate, Tin Oxide.
