<b>SECTION 2 - HAZARDS IDENTIFICATION</b>

Inactive Ingredients: Cyclopentasiloxane, Stearyl Alcohol, C12-15 Alkyl Benzoate, PPG-14 Butyl Ether, Hydrogenated Castor Oil, Petrolatum, Talc, Phenyl Trimethicone, Cyclodextrin, Fragrance, Mineral Oil, Behenyl Alcohol.

The product(s) does not contain ingredients considered hazardous as defined by OSHA, 29 CFR 1910.1200 and/or WHMIS under the HPA.

### SECTION 4 - FIRST AID MEASURES
