Water, Sodium Laureth Sulfate, Sodium Lauryl Sulfate, Sodium Chloride, Fragrance, Cocamidopropyl Betaine, Citric Acid, Sodium Benzoate, Disodium EDTA, Methylchloroisothiazolinone, Methylisothiazolinone, Yellow 5, Green 3.
