Water, Stearyl Alcohol, Behentrimonium Methosulfate, Cetyl Alcohol, Fragrance, Bis-Aminopropyl Dimethicone, Isopropyl Alcohol, Benzyl Alcohol, Disodium EDTA, Panthenol, Panthenyl Ethyl Ether, Methylchloroisothiazolinone, Methylisothiazolinone.

The product(s) does not contain ingredients considered hazardous as defined by OSHA, 29 CFR 1910.1200 and/or WHMIS under the HPA.
