### SECTION 3 - COMPOSITION AND INGREDIENTS

Water, Stearyl Alcohol, Bis-Aminopropyl Dimethicone, Behentrimonium Methosulfate, Cetyl Alcohol, Fragrance, Isopropyl Alcohol, Benzyl Alcohol, Disodium EDTA, Panthenol, Panthenyl Ethyl Ether, Methylchloroisothiazolinone, Methylisothiazolinone.
