Section 7. Handling and storage

Precautions for safe handling

Protective measures : Put on appropriate personal protective equipment (see Section 8). Avoid exposure - obtain special instructions before use. If during normal use the material presents a respiratory hazard, use only with adequate ventilation or wear appropriate respirator.
