## Section 4. First aid measures

## Section 5. Fire-fighting measures

### Extinguishing media

## Section 7. Handling and storage

### Precautions for safe handling

- Protective measures** : Put on appropriate personal protective equipment (see Section 8). ### Consult local authorities for acceptable exposure limits.
