**Eye contact:** If in eyes wash out immediately with water. In all cases of eye contamination it is a sensible precaution to seek medical advice.

## 6. ACCIDENTAL RELEASE MEASURES

### SMALL SPILLS

### LARGE SPILLS

Wear protective equipment to prevent skin and eye contamination and the inhalation of dust. Work up wind or increase ventilation. Cover with damp absorbent (inert material, sand or soil). Sweep or vacuum up, but avoid generating dust. Collect and seal in properly labelled containers or drums for disposal. ## 7. HANDLING AND STORAGE

**Handling:** Avoid skin and eye contact and inhalation of dust.

TWA - The time-weighted average airborne concentration over an eight-hour working day, for a five-day working week over an entire working life.

STEL (Short Term Exposure Limit) - the average airborne concentration over a 15-minute period, which should not be exceeded at any time during a normal eight-hour workday.

These Exposure Standards are guides to be used in the control of occupational health hazards. All atmospheric contamination should be kept too as low a level as is workable.
