Water, Saccharomycopsis Ferment Filtrate, Butylene Glycol, Pentylene Glycol, Ascorbyl Glucoside, Allantoin, Hydrolyzed Rice Bran Extract, Gentiana Lutea Root Extract, Phenoxyethanol, Xanthan Gum, Sodium Citrate, Disodium EDTA, Sodium Hydroxide, Sodium Salicylate, Methylparaben.
