### 4. FIRST AID MEASURES

If poisoning occurs, contact a doctor or Poisons Information Centre (Phone Australia 131 126, New Zealand 0800 764 766).

**Inhalation:** Remove victim from exposure - avoid becoming a casualty. Remove contaminated clothing and loosen remaining clothing. Allow patient to assume most comfortable position and keep warm. Keep at rest until fully recovered. Seek medical advice if effects persist.

**Skin contact:** If skin or hair contact occurs, remove contaminated clothing and flush skin and hair with running water. If swelling, redness, blistering or irritation occurs seek medical assistance.

**Eye contact:** If in eyes wash out immediately with water. In all cases of eye contamination it is a sensible precaution to seek medical advice.

**Ingestion:** Rinse mouth with water. If swallowed, do NOT induce vomiting. Give a glass of water to drink. Never give anything by the mouth to an unconscious patient. If vomiting occurs give further water. Seek medical advice.

## 5. FIRE-FIGHTING MEASURES

## 6. ACCIDENTAL RELEASE MEASURES

### SMALL SPILLS

Wear protective equipment to prevent skin and eye contamination. Avoid inhalation of dust. Wipe up with absorbent (clean rag or paper towels). Allow absorbent to dry before disposing with normal household garbage.

### LARGE SPILLS

Wear protective equipment to prevent skin and eye contamination and the inhalation of dust. Work up wind or increase ventilation. Cover with damp absorbent (inert material, sand or soil). Sweep or vacuum up, but avoid generating dust. Collect and seal in properly labelled containers or drums for disposal. Slippery when spilt. Avoid accidents, clean up immediately.

If contamination of sewers or waterways has occurred advise local emergency services.

## 7. HANDLING AND STORAGE

**Handling:** Avoid skin and eye contact and inhalation of dust.

**Storage:** Store in a cool, dry, well-ventilated place and out of direct sunlight. Store away from foodstuffs. Store away from incompatible materials described in Section 10. Keep containers closed when not in use - check regularly for spills.

No Exposure Standards assigned to other constituents.

These Exposure Standards are guides to be used in the control of occupational health hazards. All atmospheric contamination should be kept as low a level as is workable. These exposure standards should not be used as fine dividing lines between safe and dangerous concentrations of chemicals. They are not a measure of relative toxicity.

If the directions for use on the product label are followed, exposure of individuals using the product should not exceed the above standard. The standard was created for workers who are routinely, potentially exposed during product manufacture.

**Biological Limit Values:** As per the "National Model Regulations for the Control of Workplace Hazardous Substances (Safe Work Australia)" the ingredients in this material do not have a Biological Limit Allocated.

**Engineering measures:** Ensure ventilation is adequate to maintain air concentrations below Exposure Standards. Use only in well ventilated areas. Avoid generating and inhaling dusts. Use with local exhaust ventilation or while wearing dust mask. Keep containers closed when not in use.

**Personal protection equipment:** VIOLET: OVERALLS, SAFETY SHOES, SAFETY GLASSES, GLOVES, DUST MASK.

### MANUFACTURING, PACKAGING AND TRANSPORT:

Wear overalls, safety glasses and impervious gloves. Avoid generating and inhaling dusts. If dust exists, wear dust mask/respirator meeting the requirements of AS/NZS 1715 and AS/NZS 1716. Available information suggests that gloves made from butyl rubber/leather/natural rubber/neoprene/nitrile rubber/polyethylene/polyvinyl alcohol (PVA)/polyvinyl chloride (PVC)/teflon should be suitable for intermittent contact. However, due to variations in glove construction and local conditions, the user should make a final assessment. Always wash hands before smoking, eating, drinking or using the toilet. Wash contaminated clothing and other protective equipment before storing or re-using.

### CONSUMER USE:

Avoid inhaling dust. Wash hands after use.

**Hygiene measures:** Keep away from food, drink and animal feeding stuffs. When using do not eat, drink or smoke. Wash hands prior to eating, drinking or smoking. Avoid skin and eye contact and inhalation of dust. Ensure that eyewash stations and safety showers are close to the workstation location.
