**SECTION 2 - HAZARDS IDENTIFICATION**

**EMERGENCY OVERVIEW:**

**POTENTIAL HEALTH EFFECTS:**

• **Eye:**

Water, Sodium Laureth Sulfate, Sodium Lauryl Sulfate, Cocamidopropyl Betaine, Fragrance, Cocamide MEA, Sodium Chloride, Sodium Benzoate, Disodium EDTA, Citric Acid, PEG-60 Almond Glycerides, Guar Hydroxypropyltrimonium Chloride, Linoleamidopropyl PG-Dimonium Chloride Phosphate, Hydrolyzed Silk, Simmondsia Chinensis (Jojoba) Seed Oil, Oryza Sativa (Rice) Bran Oil, Sodium Citrate

### SECTION 4 - FIRST AID MEASURES
